BYLAWS REVISIONS

Why did we rewrite the bylaws?

- It was deferred action from last year.
 - The board organization changed, and the new descriptions weren't added.
 - Several of the bylaws needed updated language.
 - 1) One rule said that the annual meeting had to be held in January or February.
 - 2) Another rule needed to be changed to more clearly define the term of office.
 - There was a bylaw that simply needed to be dropped and one that needed to be added.
- The bylaws didn't allow for electronic voting for Board of Director positions.
- The bylaws only allowed for changes (to the bylaws) by vote at the annual meeting.
- The changes update the bylaws and prepare the league for the future.

ELECTRONIC VOTING: BOARD POSITIONS

Article 3 Section 1 – Election of Board of Director Members

Members will be able to submit their votes electronically. The league Secretary will conduct remote voting. The Secretary will notify the membership of the commencement of a nomination period. The nomination period will be no less than 14 days.

Members are encouraged to nominate candidates within the nomination period. Nominations received after the nomination period will be allowed but will not be on the electronic ballot. Nominations are to be submitted to the League secretary. Voting electronically will begin at least 10 days prior to the annual meeting. The voting period will be determined by the League Secretary but will be at least 3 days. The votes received electronically will be included with the tally received at the annual meeting.

This change allows the Board positions to be voted on electronically. It also sets up the ground rules for the Electronic voting. These are the rules we followed this year. This sets us up for future elections.

ELECTRONIC VOTING: BOARD POSITIONS

Article 4 Section 1 – Meetings

An annual WSSL general membership meeting will be held at the completion of the WSSL season and prior to the commencement of the following WSSL season.

Original bylaw stated the annual meeting had to be held in January or February. This change allowed us to hold the meeting anytime between seasons.

Members will be able to submit their votes electronically. The league Secretary will conduct remote voting. There will be one ballot for each member. The ballot will include all items to be voted on at the general membership meeting. A member who is nominated to a position outside of the nomination period will not be on the remote ballot. Votes received electronically will be added to the tally of votes received at the annual meeting.

The changes in Article 3 allow the voting and set up the rules for it. This change was needed to reiterate the e-voting procedures at the annual meeting.

ELECTRONIC VOTING: BYLAWS REVISIONS

Article VI – Organization Bylaw Revisions and Amendments

and by votes submitted electronically

This allows for electronic voting for Bylaws revisions.

If the Board deems there is a need to revise the bylaws at other times in the annual cycle, a similar process is followed. The Secretary will post the amended Bylaws for Membership review on the WSSL website. The Membership will be notified of the changes and where to review them. The new version will be posted for a minimum of 14 days. The Secretary will then conduct an electronic vote. Membership will be notified of commencement and end of the voting period. The voting period will be a minimum of 7 days. A majority of the submitted votes received by the Secretary will determine whether the revision is adopted.

This addition sets up how the e-voting will happen and allows for revisions between annual meetings.

BYLAWS REVISIONS: MEMBER REQUESTED

Article 1 Section 5 – Board of Director Responsibilities

Minutes of each Board of Directors' meeting will be posted by a link on the homepage, or readily available section, of the league website within 30 days of each meeting

Pros:

- Will provide members more information.
- Other similar organizations provide the minutes to their members.

Cons:

- The meeting update from the commissioner is already provided and is adequate.
- There are discussions at the meetings that are of a sensitive nature (Regarding members and Sponsors).
- Minutes would need to be "scrubbed" prior to posting.


Yorktown Division President Nominee: Mark Metivier
